

Summer 2024 Financial Aid Information

IMPORTANT: Any financial aid you were awarded for Fall 2023 and Spring 2024 that you haven't used - that is leftover - can be used for summer. If you attended both fall 2023 and spring 2024 terms as a full-time student either here at FDLTCC or at another college, **you may not have any remaining financial aid** that can be used to pay for summer session courses. If, however, you were **not** enrolled as a full-time student both fall and spring terms, you may have some remaining grant and/or loan eligibility.

If you do not want to register for your courses without knowing whether you have financial aid eligibility to cover the costs, contact the Financial Aid Office. There is no summer financial aid application. Once you have registered for summer classes, we will calculate and post your Summer Estimated Award to your e-Services account and send you an e-mail when it is available online.

Accessing your Summer Award info. Once it's processed, go to Fond du Lac Tribal & Community College's website (fdltcc.edu) > Log In > Campus Account Access > Enter Star ID and Password > Financial Aid > select the correct term > select Summer Session 2024 > Awards by Credit Level.

Borrowing a Direct Student Loan. If you received your Summer Award Notification prior to the end of Spring semester and have loan eligibility listed on your Summer Estimated Award, you may be able to borrow those funds during Spring Semester, and we recommend that you do. This will guarantee that you have loan funding regardless of the number of credits that you take during the summer term. To borrow a student loan during Summer you must be enrolled for 6 or more credits AND have Direct Loans listed on your Summer Estimated Award.

- To submit a Loan Request for summer go to <u>eServices account</u> (<u>fdltcc.edu</u>) > *Login* (upper right) > Campus Account Access > log in > Financial Aid > select the correct term > "Summer Session 2024" > Loans > and complete the Loan Request Form.
- If you have not already received a Direct Student Loan at FDLTCC this year, you must complete:
 - 1. Entrance Loan Counseling (for Undergraduate student, NOT PLUS) at Loan Application Website (studentaid.gov)
 - 2. A Master Promissory Note (for Undergraduate student, NOT PLUS) at Loan Application Website (studentaid.gov)

Charging Books. Students who have an Estimated Summer Award indicating they are eligible for summer financial aid will be allowed to charge their books in the bookstore through the end of the first week of summer session. A list of eligible students will be given to the bookstore. There is no need to stop into the Financial Aid Office for a book voucher.

Payment of tuition. Students who are eligible for grant money or have applied for a summer loan will have the payment of their tuition deferred until disbursement. If you are not eligible for Financial Aid, a down payment is required fifteen business days before the first day of Summer Session. The down payment is \$300 or 15% of your summer session tuition, whichever is lower. The due date is May 6, 2024. If you cannot pay the balance in full before the start of the term, a deferment payment plan may be processed through the Business Office. This also must be done by May 6, 2024.

Disbursement of Financial Aid. Disbursement will begin on June 7, 2024. Your financial aid will first be used to pay for your tuition, fees, and books. Any excess funds will be disbursed via BankMobile using the method you chose when you set up your BankMobile Account.
