

Dear Prospective Lady Thunder Basketball Player:

I hope this letter finds you all enjoying the last few weeks before school begins. This packet includes a player checklist that should be completed before arrival. August 19th is the mandatory report date. **Important — Report Date is before Noon August 19th.** So, anytime from August 16–18th I is acceptable.

It is **your** responsibility to arrive here on time. Make Travel arrangements to FDLTCC — for players arriving by bus or plane the closest destination cities are Duluth or Minneapolis. Players arriving at the Duluth airport (DLH) should coordinate and schedule a ride from the airport with Coach Smith. Players arriving from Minneapolis Airport should schedule a ride with Groome Transportation from Minneapolis-St. Paul (MSP) airport to Scanlon Park & Ride, from there, schedule a ride with Coach Smith to pick you up. Players arriving by bus there is a bus station in Cloquet, Minnesota, schedule a ride to be picked up from the bus station with Coach Smith.
