## **Special Program Requirements:**

- Students must attain a grade of "C" or better in all CJPO courses and a final cumulative GPA of 2.0 or higher to graduate.
- Courses required for Minnesota P.O.S.T. licensing must be completed within three (3) years of starting the certificate.
- Students must have a valid Emergency Medical Responder certification (or higher) at the time of the Post Board Exam. (This may be taken as a credit-based class (HLTH 1050) or as a non-credit option.
