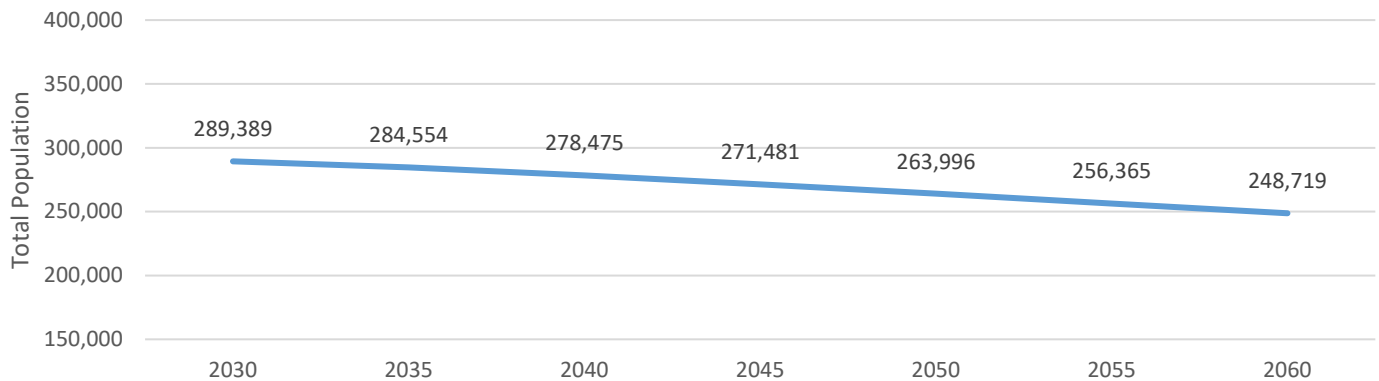

MN Region 03 - Arrowhead, 30-Year Population Projection, 2030-2060

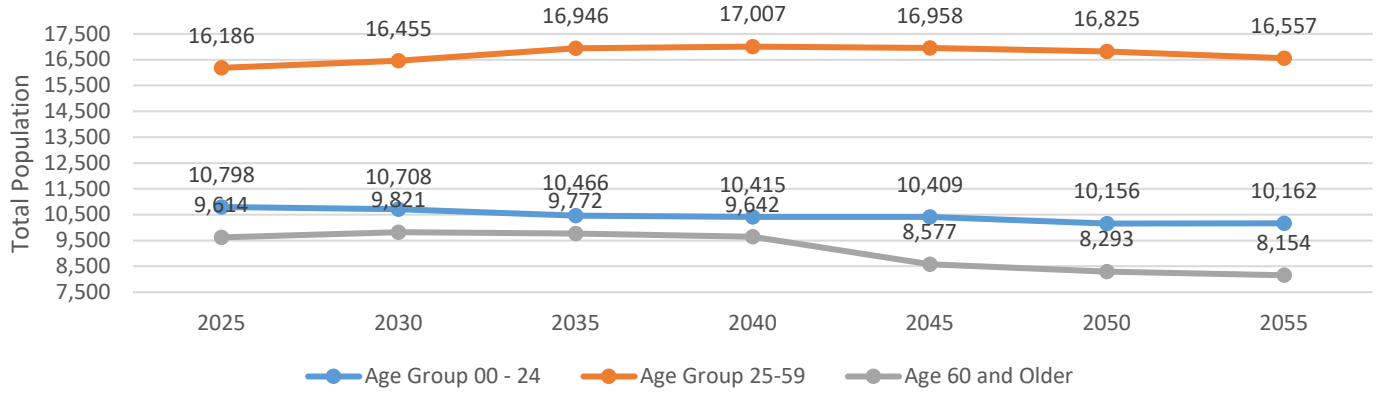

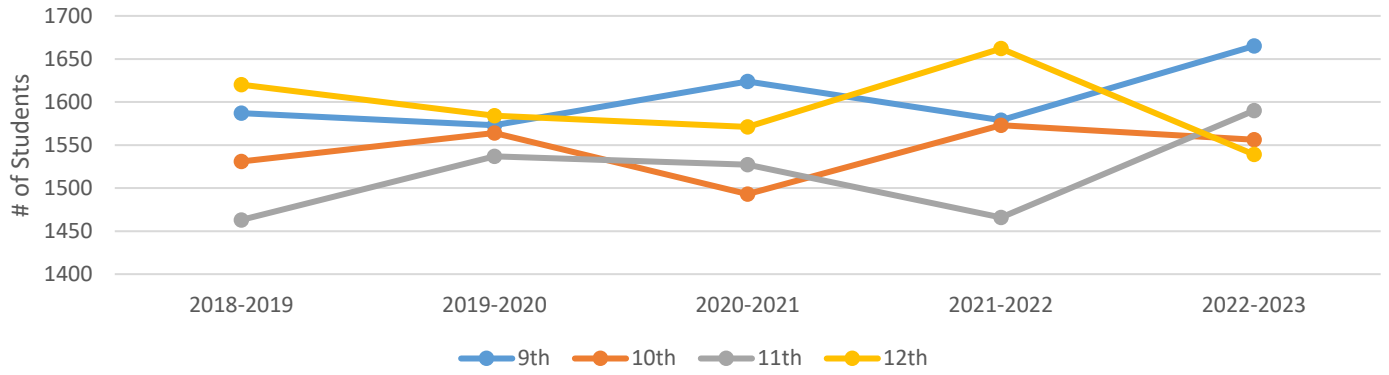

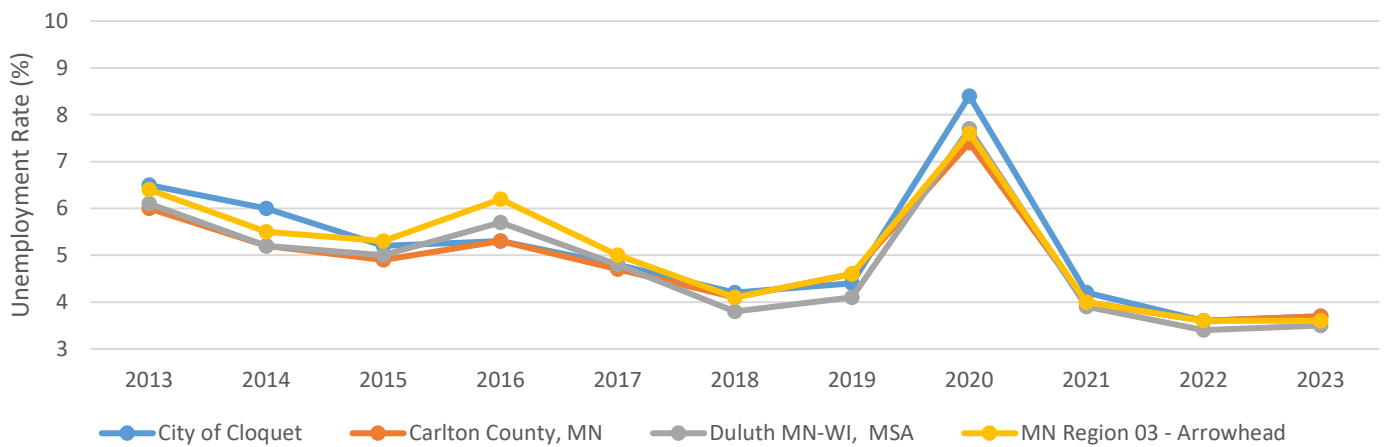
Area School District Enrollment Trends by Grade

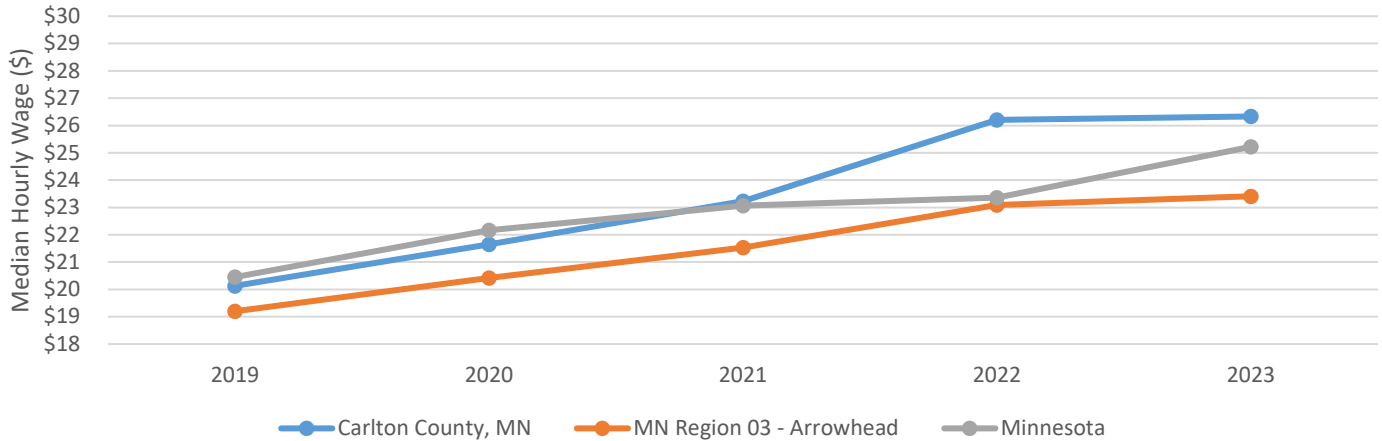

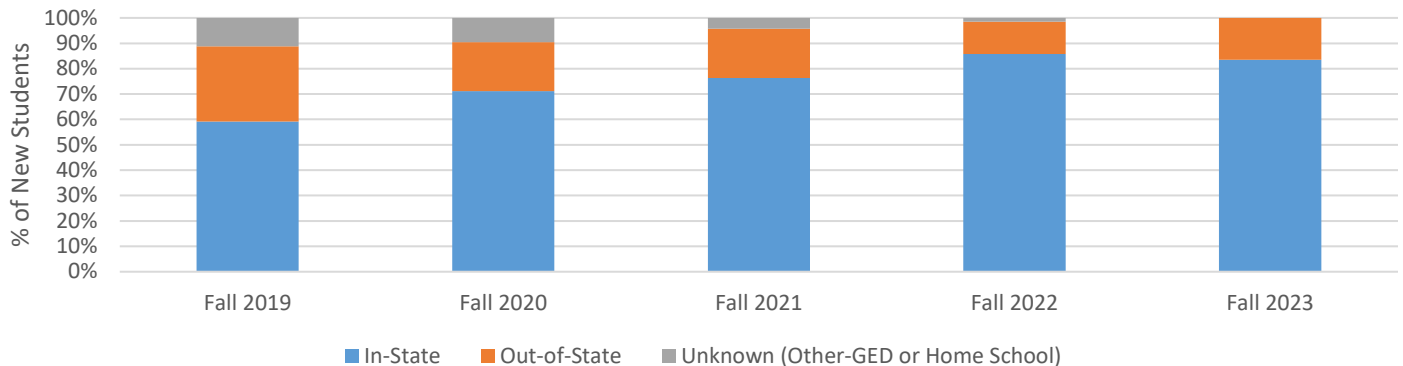

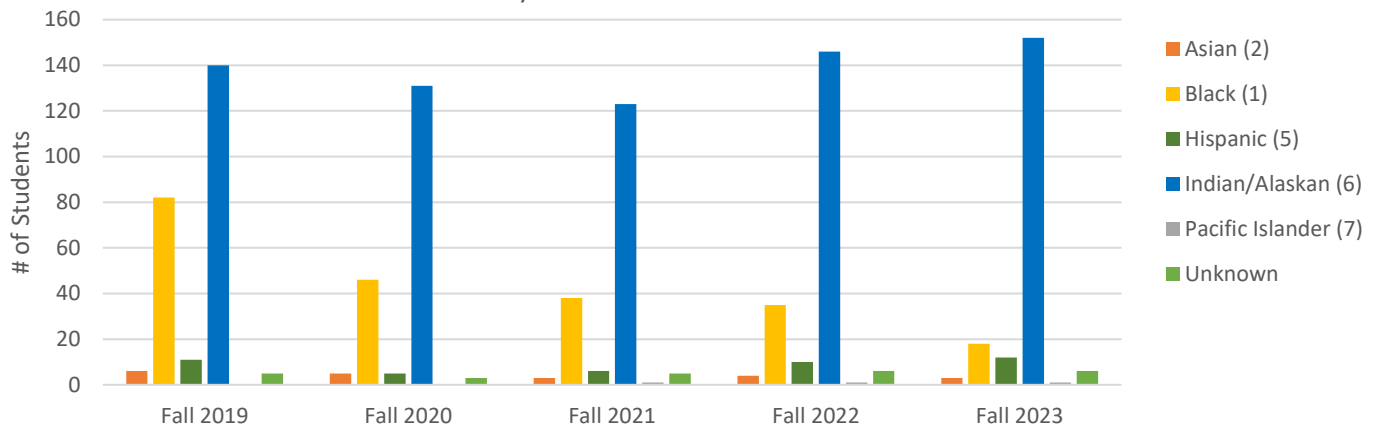

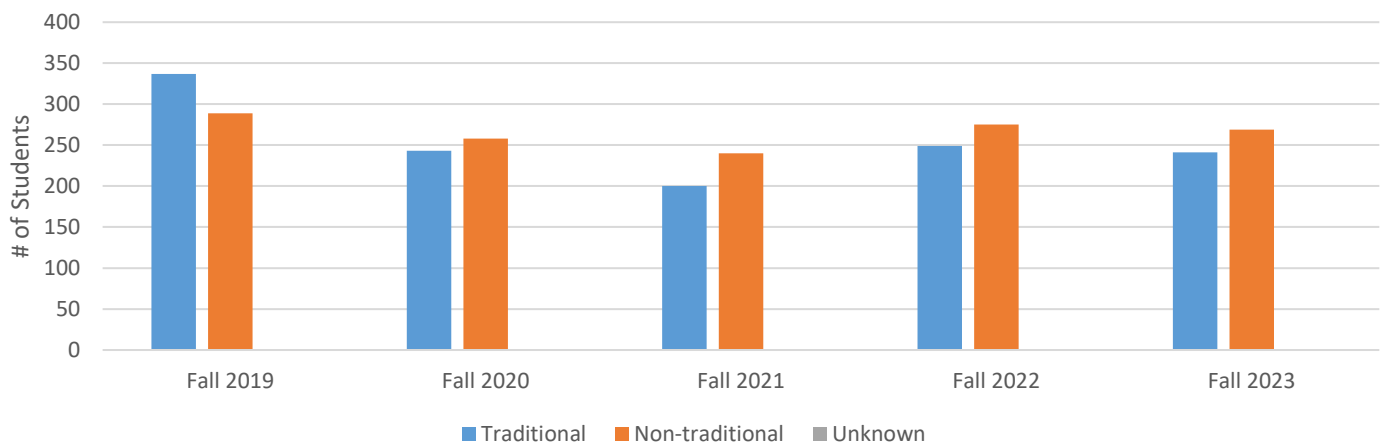

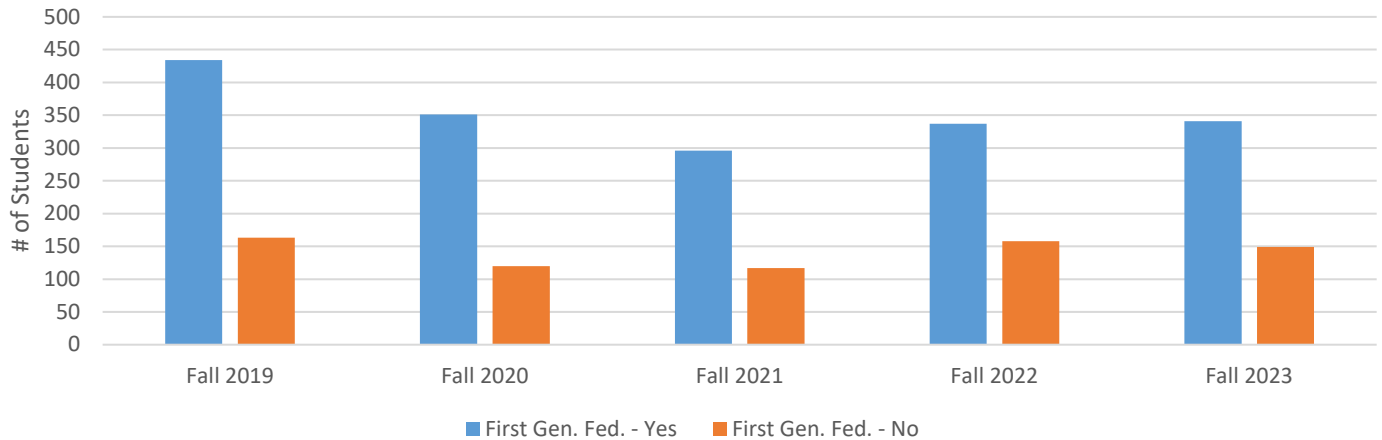

Undergraduate Enrollment by Fiscal Year

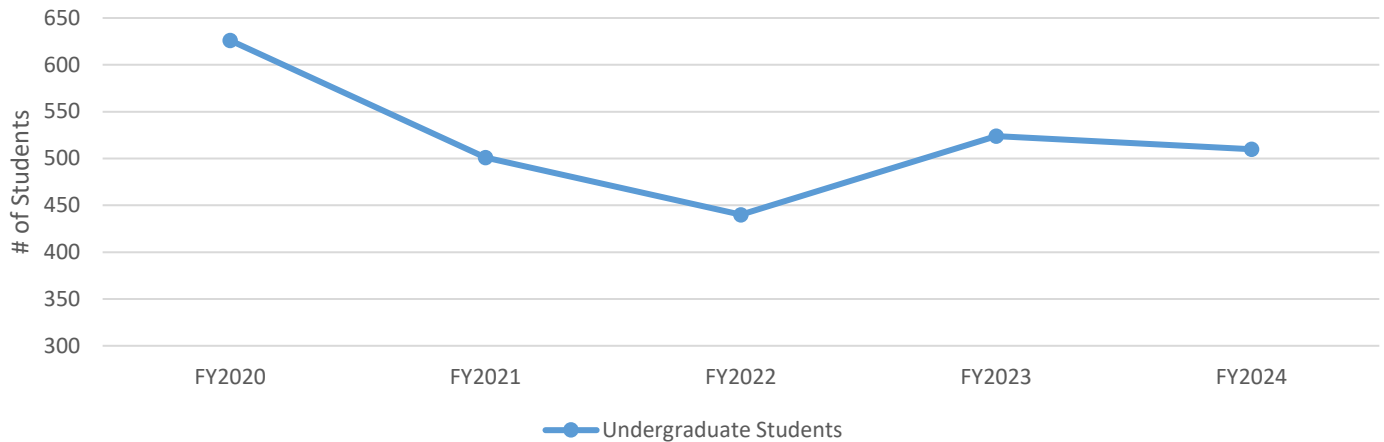

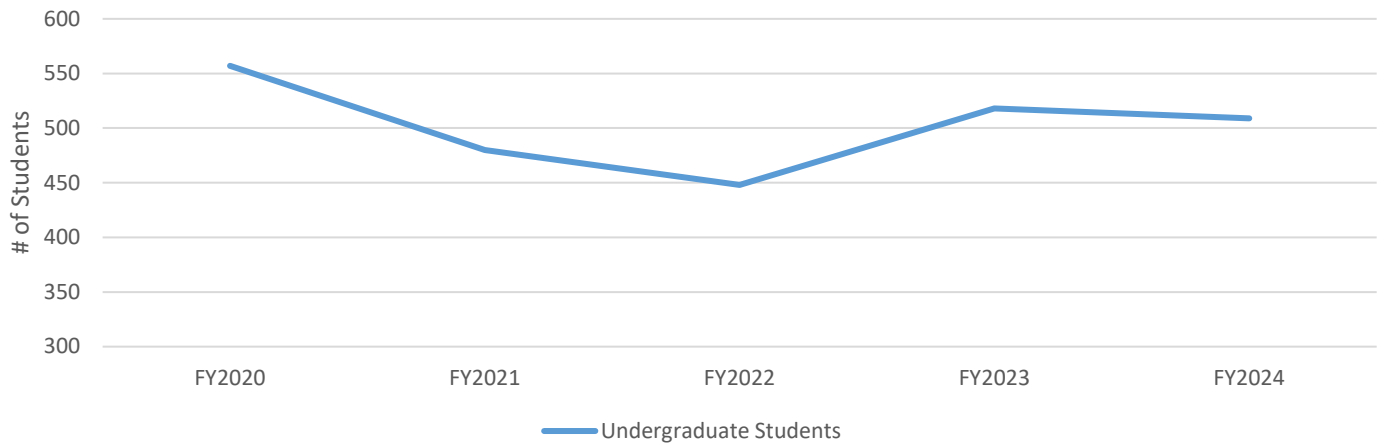

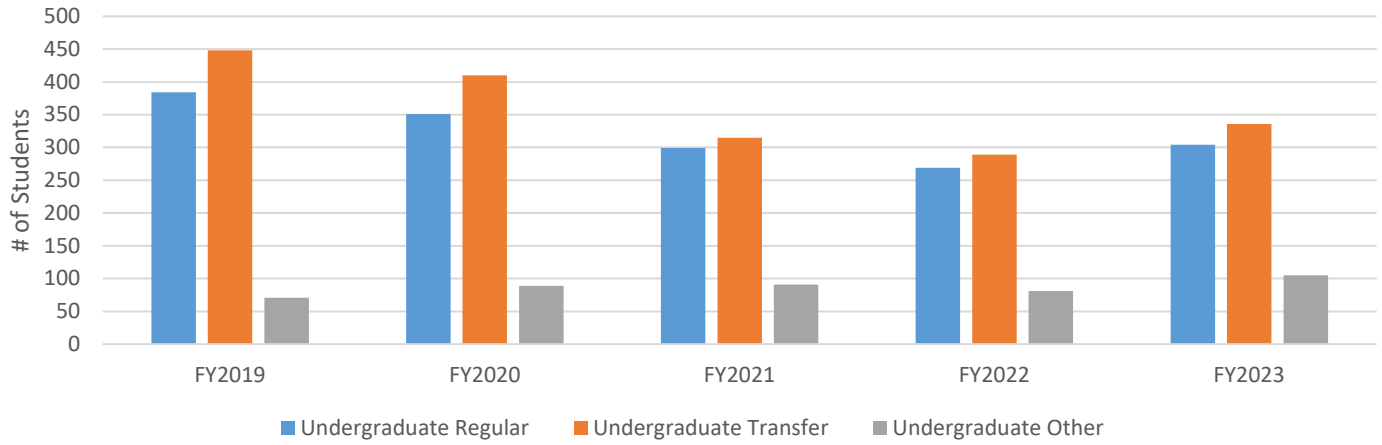

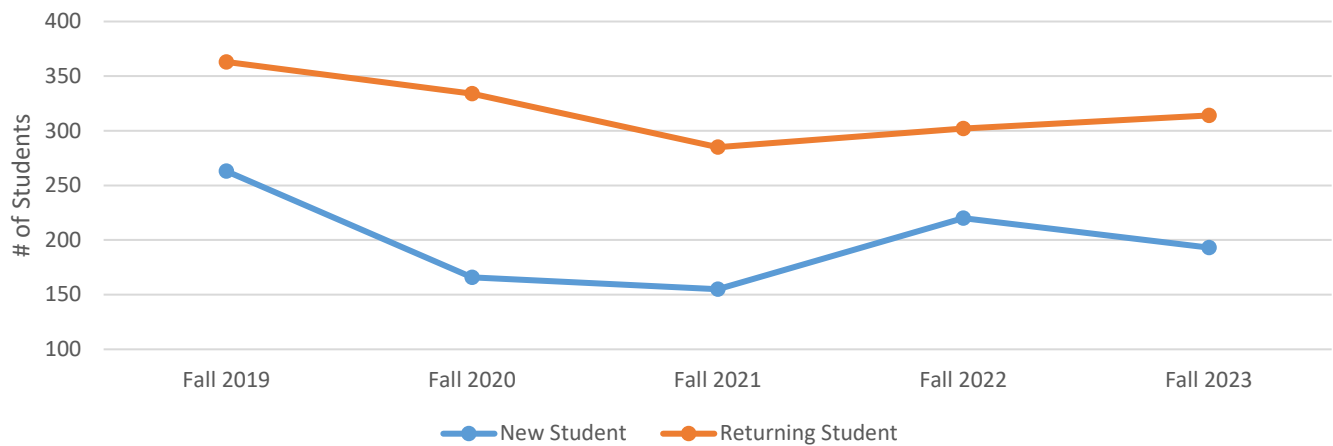

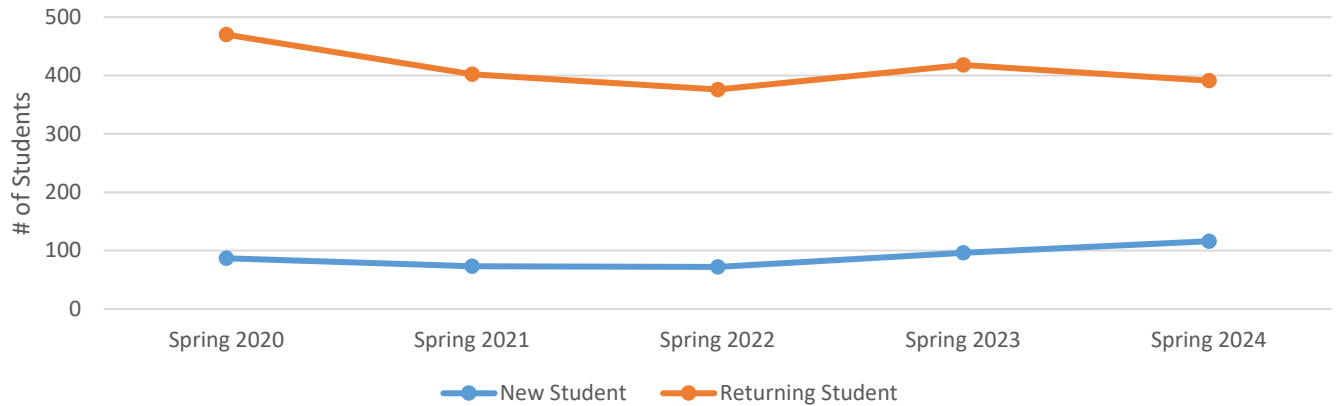

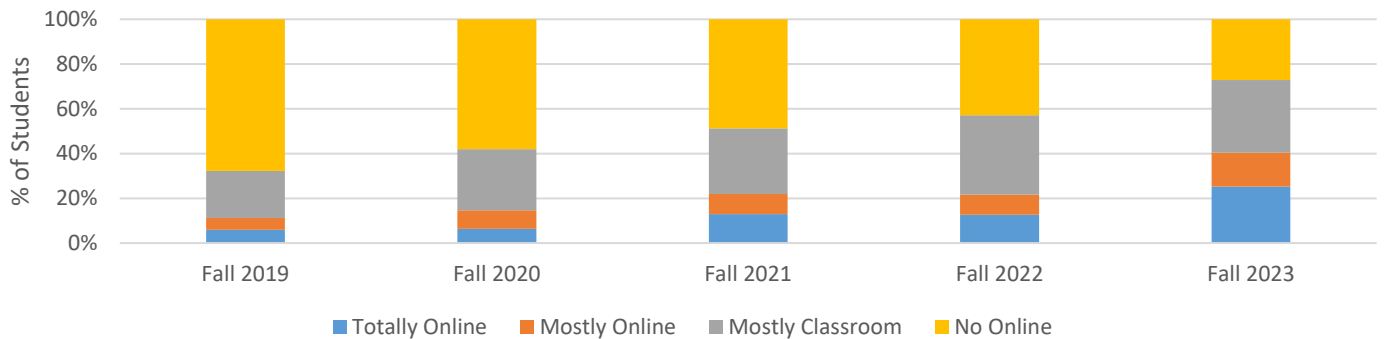

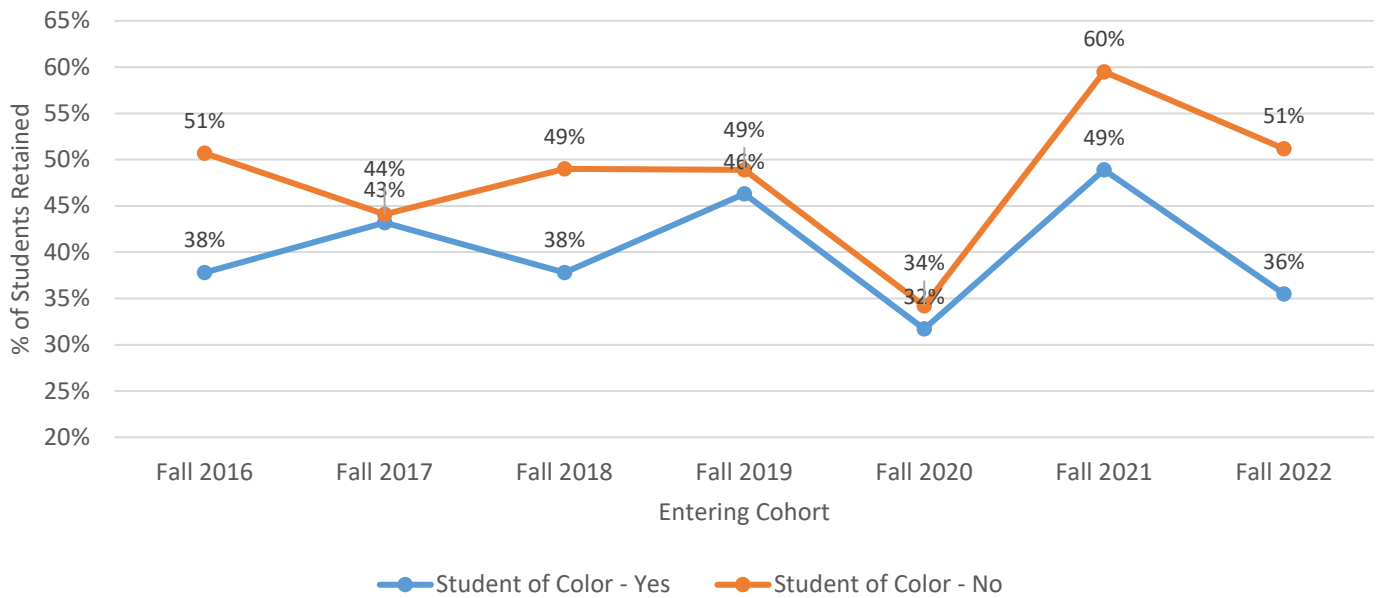

2nd Fall Retention (Full-time and Part-time) by Student of Color

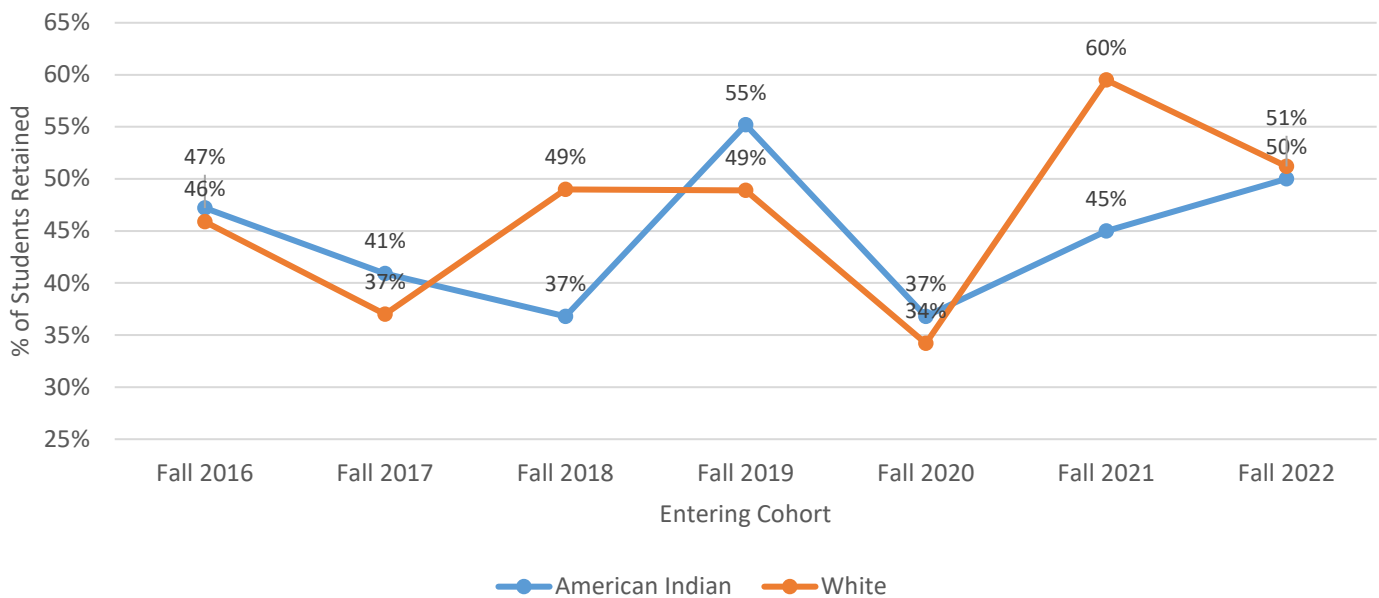

2nd Fall Retention (Full-time and Part-time) by American Indian Race/Ethnicity

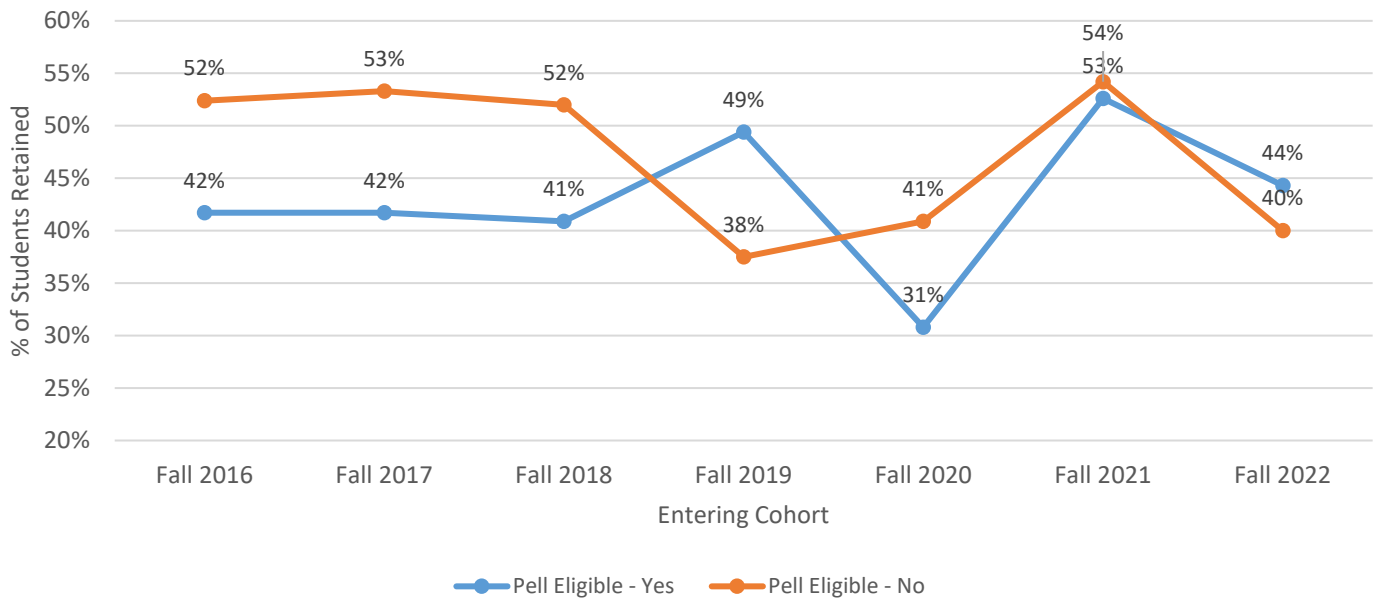

2nd Fall Retention (Full-time and Part-time) by Pell Eligible

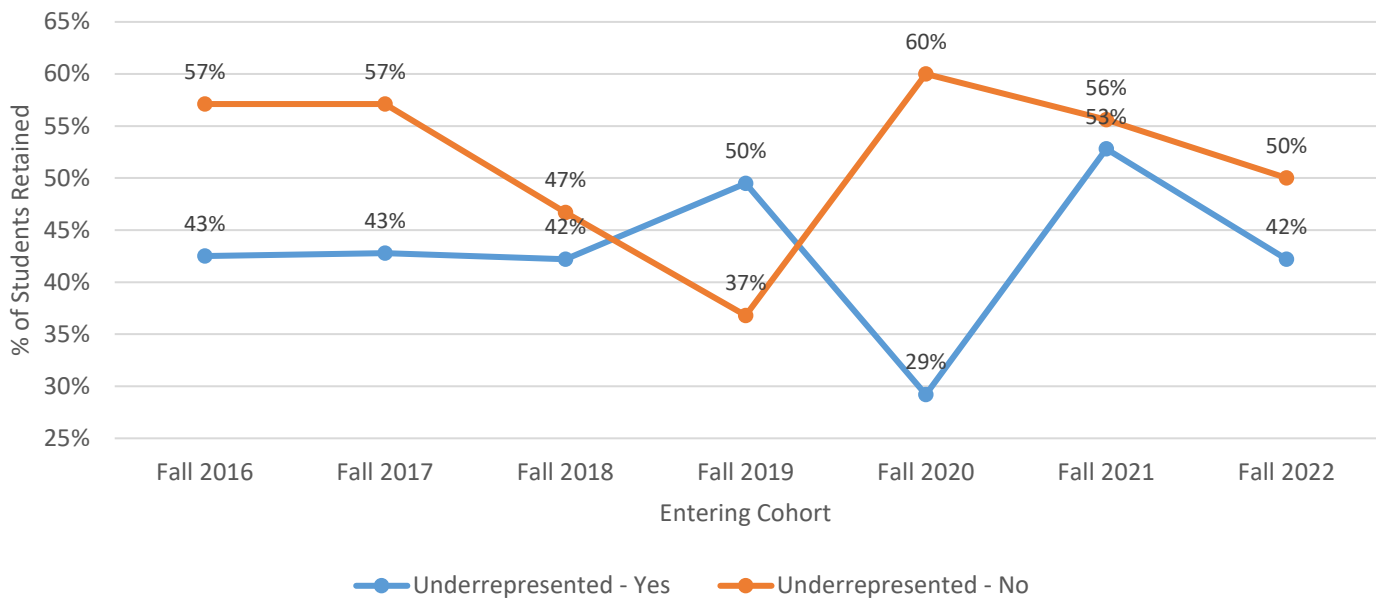

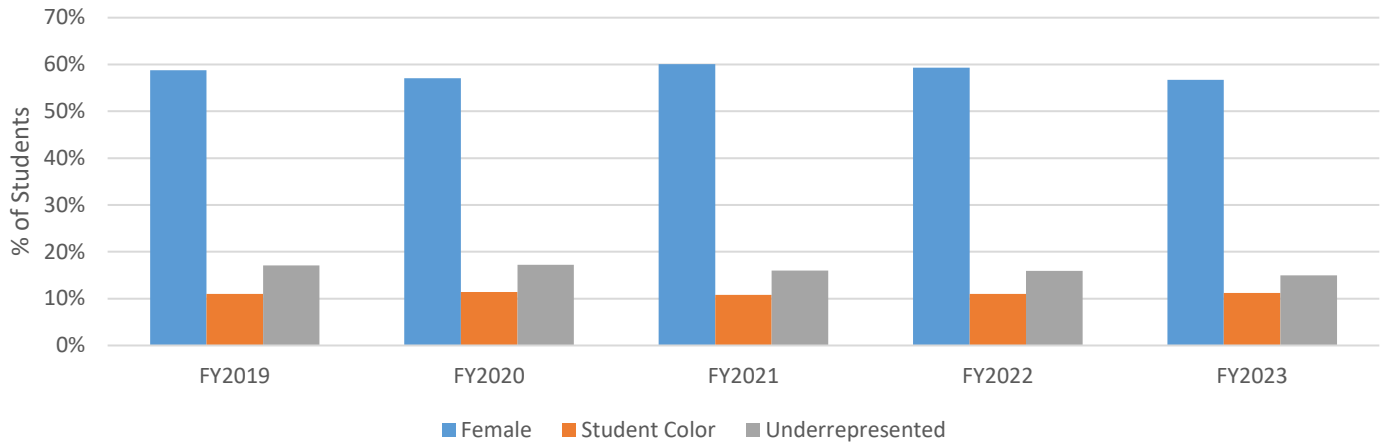

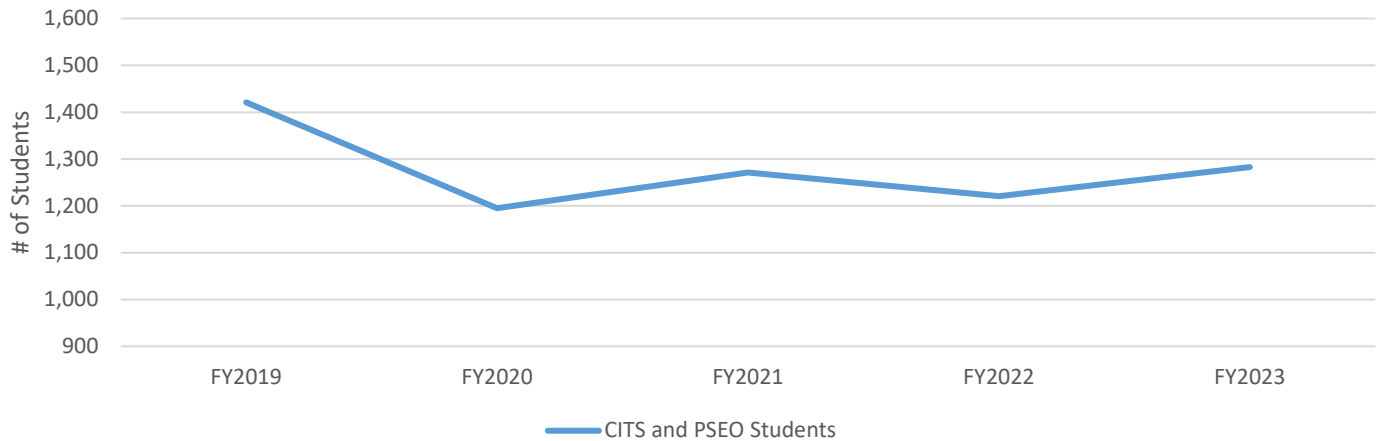

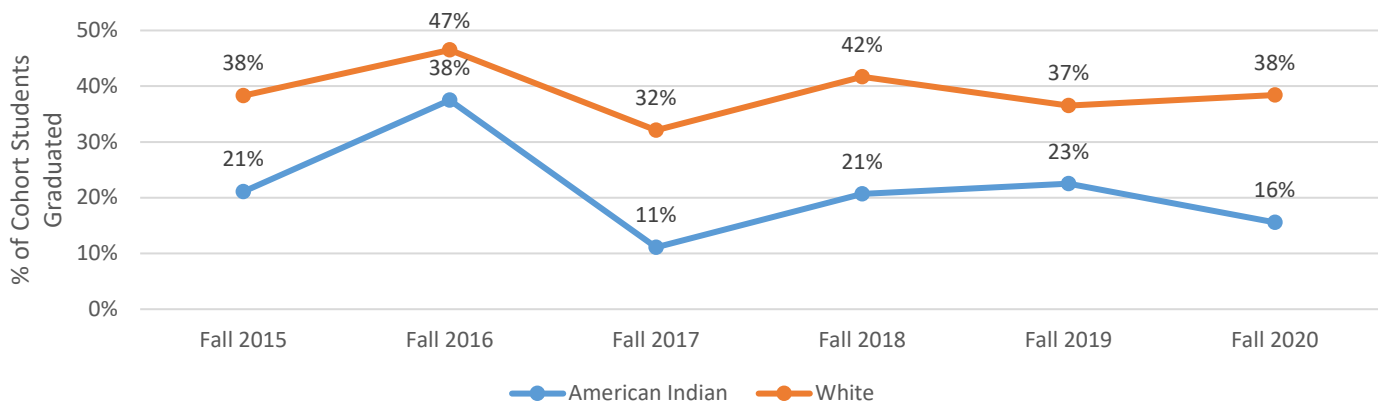

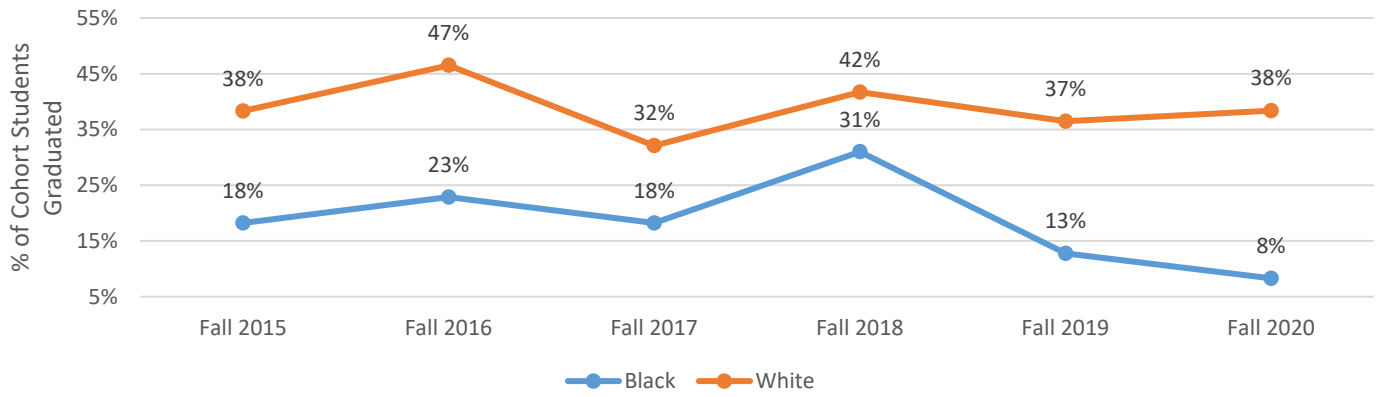

4th Fall Graduation Rate by American Indian Race/Ethnicity



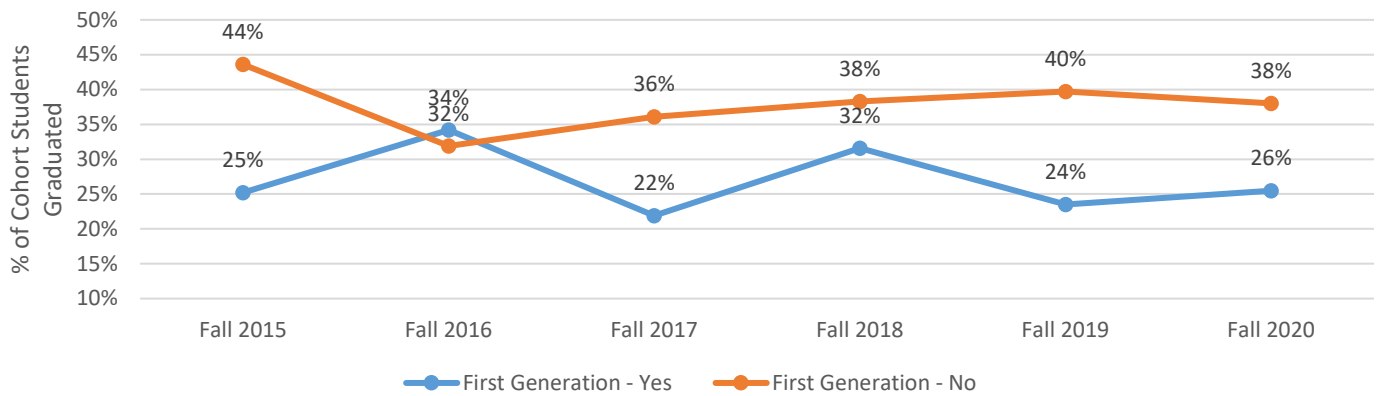

4th Fall Graduation Rate by Black Race/Ethnicity



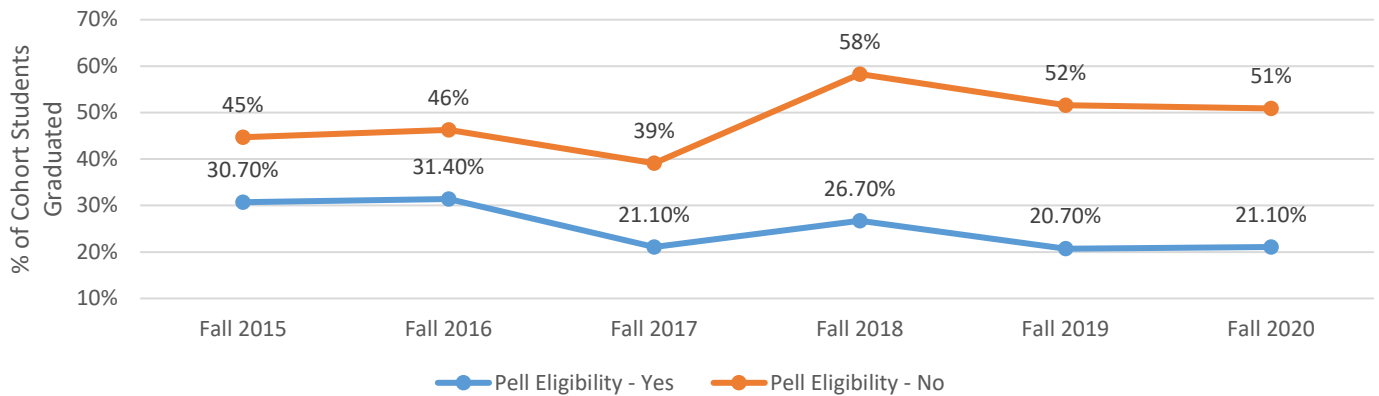

4th Fall Graduation Rate by First Generation College



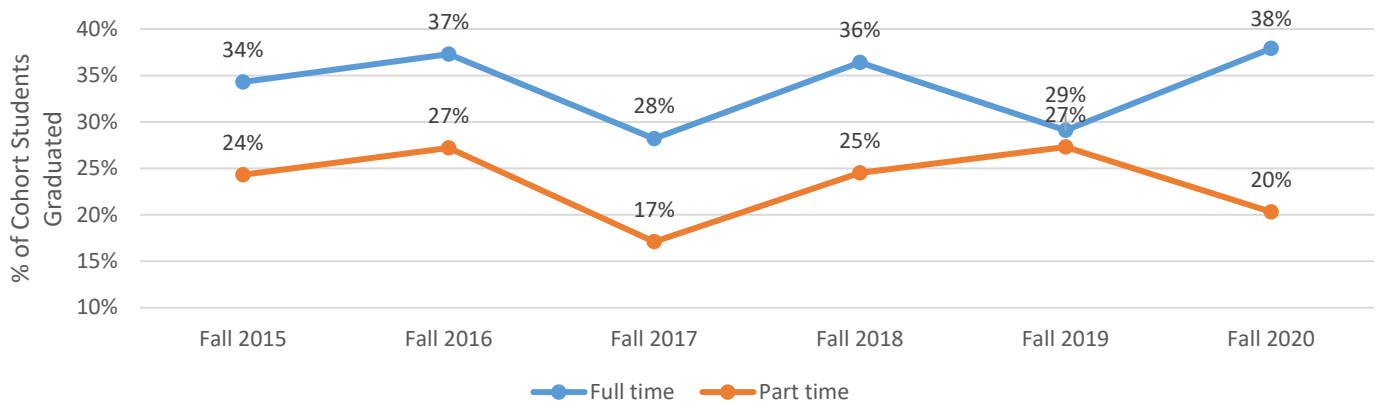

4th Fall Graduation Rate by Pell Eligibility

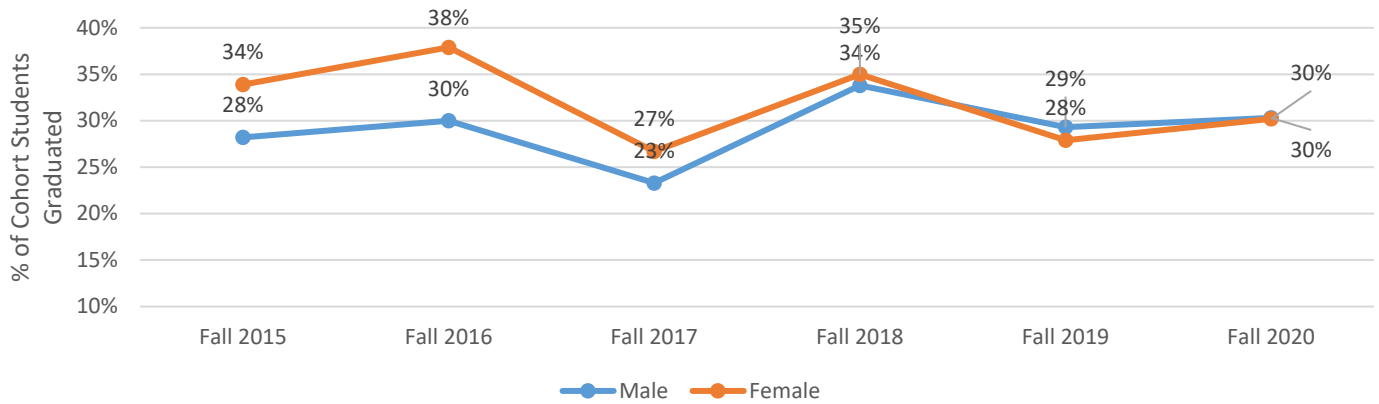

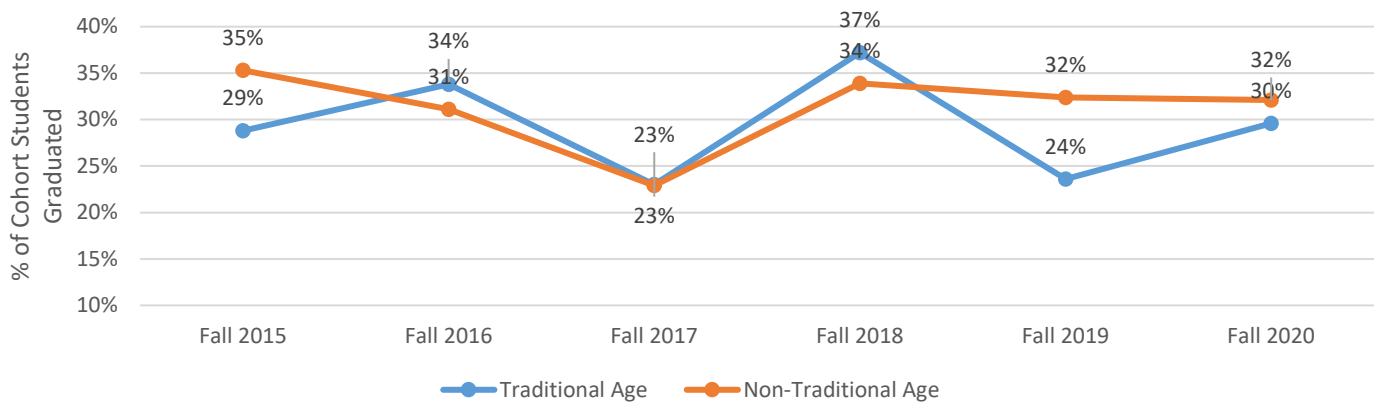
4th Fall Graduation Rate by Full and Part-time Enrollment Status at Entry

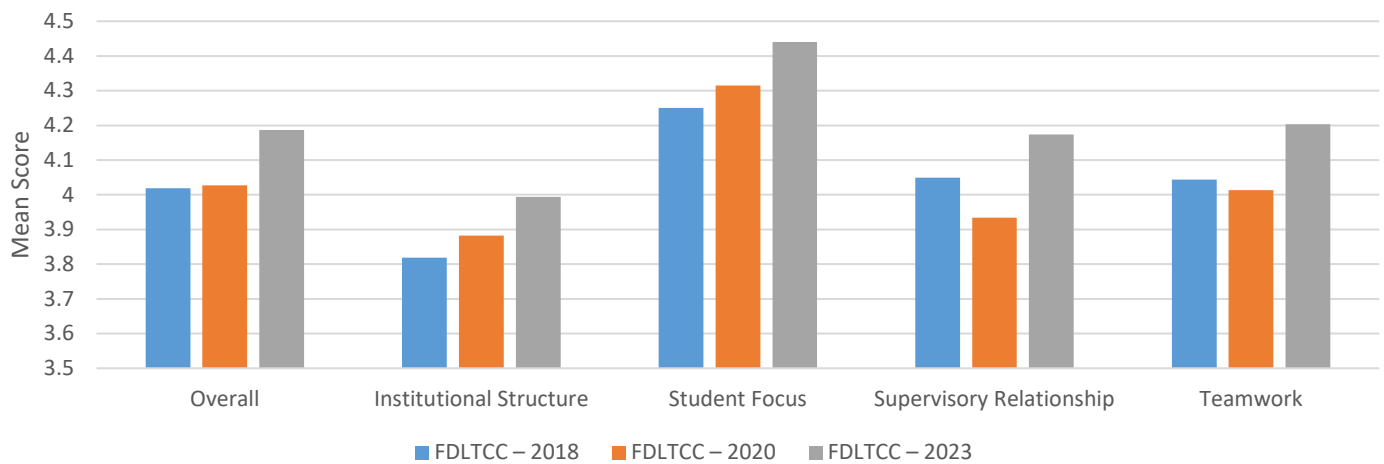

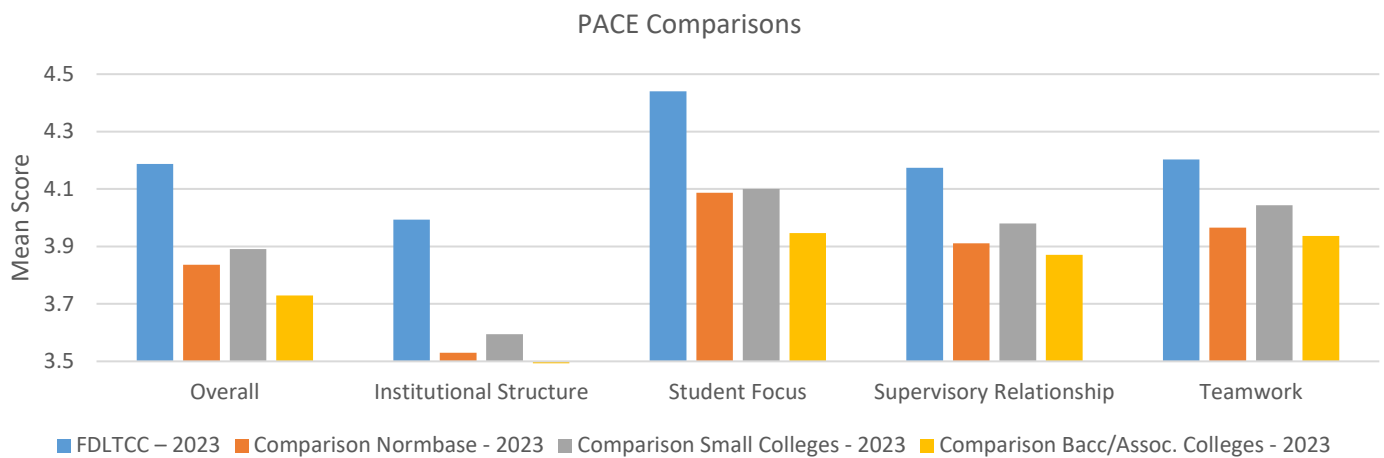
Nilie PACE Report Survey

The National Initiative for Leadership & Institutional Effectiveness (NILIE) PACE Report surveys institutional culture. FDLTCC last administered the survey in spring 2023. The survey was administered to employees, sixty-two completed and returned the instrument for analysis. The PACE is a 46-item instrument organized into four climate factors. FDLTCC has three survey result populations to compare with. The overall survey group – Normbase. Colleges with less than 2,000 students enrolled – Small Colleges. 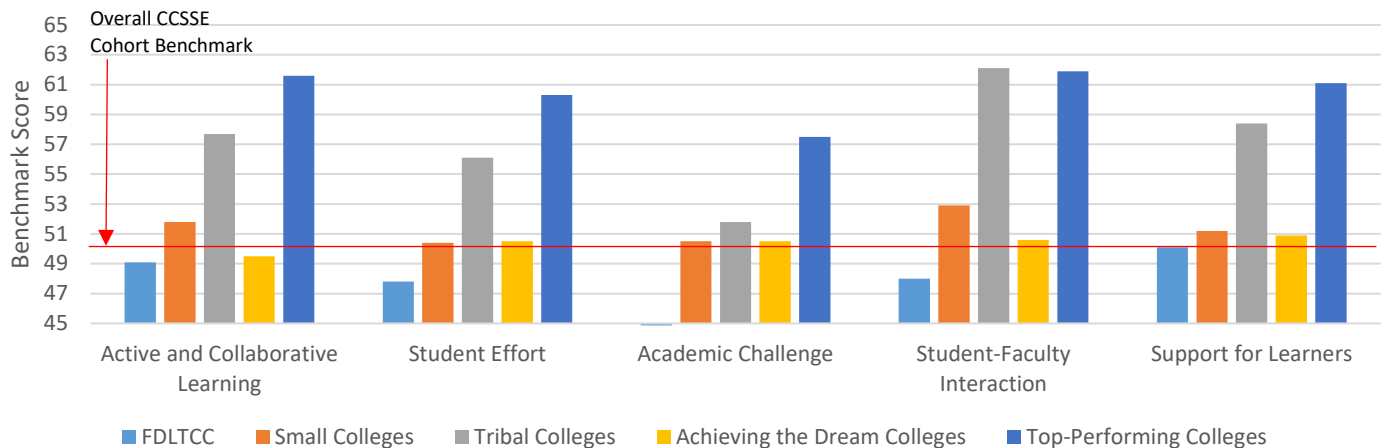

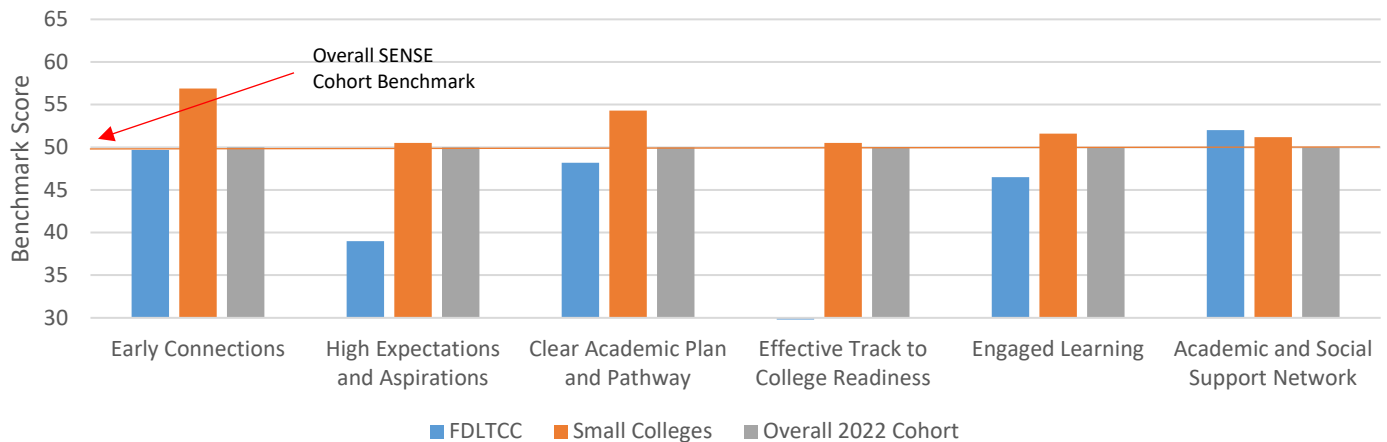
