

## Application for DEET Academic Scholarship Environmental Science - Spring 2025

The Development of Enhanced Education and Training (DEET) Project seeks to increase student access, interest, and success in future Food, Agriculture, and Natural and Human Sciences (FANH) career pathways.

## **Project goals include:**

- 1. Support students throughout their educational journey with academic and financial assistance with access to mentoring, peer-to-peer learning, and scholarships
- 2. Provide experiential learning opportunities for college students to explore FANH disciplines through field trips, research projects, internships, and camps.
- 3. Increase student interest in food and agriculture careers through community outreach, career counseling, and professional development.

DEET Academic Scholarships support students pursuing an Environmental Science A.S. degree, Geographic Information (GIS) A.S. degree, Biology Transfer Pathway A.S., or GIS or Sustainability Certificate programs. The DEET scholarship can provide up to \$2000 per semester (full-time student) or \$1,000 (part-time student). Scholarships are limited. An eligible student can apply for up to six (6) semesters of support. Check with the Financial Aid office to determine how this scholarship may reduce other Financial Aid eligibility.

By applying for the DEET Academic scholarship you are agreeing to meet requirements of DEET scholarship, which include all the following:

- You are a FDLTCC student who is currently pursuing either of the following: Environmental Science A.S.
  degree, Biology Transfer Pathway A.S., Geographic Information A.S. degree, or Environmental
  Sustainability or Geographic Information Systems Certificate, and taking a minimum of six (6) credits at
  FDLTCC.
- Your cumulative GPA is 2.0 or above to apply for the DEET Academic Scholarship.
- Remain in good academic standing in your classes throughout the semester.
- Pass 75% of your classes by the end of the semester.
- Provide information on your academic status and progress, as needed, and required with this application.
- Communicate regularly with the DEET Coordinator regarding any changes to your enrollment status and keep DEET Coordinator updated on your education goals and current classes.
- If receiving a failing grade, students will develop a support plan and will communicate with DEET Coordinator on a plan for academic success.
- Students are required to reapply for the DEET scholarship each semester (available in fall and spring)
- Participate in at least (4) DEET activities/events. Mandatory activities/events include but not limited to: College preparation, shared visits with Leech Lake Tribal College students, Earth Week activities, and the Research Symposium in April.
- Submit application by January 27, 2025, by 4:00 p.m. deadline.
- Qualified applicants will be awarded on a first come, first served basis.
- Complete DEET application and email or drop it off to Maria DeFoe at the Environmental Institute.
